# 4. FIRST AID MEASURES

**Inhalation:** Remove the source of contamination or move the victim to fresh air. Ensure airways are clear and have a qualified person give oxygen through facemask if breathing is difficult. Seek immediate medical attention.

#### 5. FIRE FIGHTING MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

**Emergency procedures:** Remove all sources of ignition. Increase ventilation. Evacuate all unnecessary personnel. Wear full protective equipment and clothing to minimize exposure. If possible, contain the spill.

**Methods and materials for containment and clean up:** Place inert, non-combustible, absorbent material onto spillage. Use clean non-sparking tools to collect the material and place into a suitable labelled container. If large quantities of this material enter the waterways contact the Environmental Protection Authority, or your local Waste Management Authority.

#### 7. HANDLING AND STORAGE

**Conditions for safe storage:** Limit all unnecessary personal contact. Wear protective clothing when risk of exposure occurs. Use in a well-ventilated area. Avoid contact with incompatible materials. When handling, DO NOT eat, drink or smoke. Keep containers securely sealed when not in use. Avoid physical damage to containers. Always wash hands with soap and water after handling. Work clothes should be cleaned separately. Use in a well-ventilated area.

# 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Occupational Exposure Limits: No exposure standards have been established for this material by the National Occupational Health And Safety Commission (NOHSC). However, all exposure should be kept to the least possible levels as over-exposure to any chemical may result in enhancement of pre-existing adverse medical conditions and/or allergic reactions. Exposure standards for individual constituents are listed above.

**Engineering controls:** Ensure ventilation is adequate and that air concentrations of components are controlled below quoted Exposure Standards. Keep containers closed when not in use. Vapour heavier than air – prevent concentration in hollows or sumps. DO NOT enter confined spaces where vapour may have collected. Where vapours or mists are generated, particularly in enclosed areas, and natural ventilation is inadequate, a flameproof exhaust ventilation system is recommended.

## **Personal Protective Equipment:**

Respiratory Protection: Avoid breathing of vapours/mists. Where ventilation is inadequate and vapours/mists are generated, the use of an approved respirator with filter complying with AS/NZS 1715 and AS/NZS 1716 is recommended; however final choice of appropriate breathing protection is dependent upon actual airborne concentrations and the type of breathing protection required will vary according to individual circumstances. Expert advice may be required to make this decision.
